

# KIRKWOOD CITY COUNCIL KIRKWOOD CITY HALL April 7, 2016 7:00 p.m.

Pursuant to notice of meeting duly given by the Mayor, the City Council convened on Thursday, April 7, 2016, at 7:00 p.m. at Kirkwood City Hall, 139 South Kirkwood Road, Kirkwood, Missouri. Present were Mayor McDonnell, Council Members Biedenstein, Jaksetic, Luetzow, Sears, and Ward. Also in attendance were Chief Administrative Officer Russell Hawes, City Clerk Betty Montaño, and City Attorney John Hessel. Council Member Griffin was absent and excused.

#### **PRESENTATIONS**

Vi Skillman from the City of Wentzville, chair of the MoCCFOA Public Relations Committee along with Susan Lane from the City of O'Fallon and Jodi Schneider from the City of Troy presented the Missouri Registered City Clerk Designation to Deputy City Clerk Laurie Asche. The City Council was thanked for its commitment to continued education for the City Clerk and Deputy City Clerk.

#### **PUBLIC HEARINGS**

Mayor McDonnell recessed the meeting for the purpose of conducting a public hearing regarding a request to amend Section A-530 of the Zoning Code to allow Learning Centers as a permitted use in the B-4 Zoning District. Mr. Hessel entered the following exhibits into the record: an Affidavit of Publication in the St. Louis Countian on March 9, 2016, as Exhibit 1; an Affidavit of Publication in the Webster Kirkwood Times on March 11, 2016, as Exhibit 2; the report of the Planning and Zoning Commission dated March 3, 2016, as Exhibit 3; the Planning and Zoning Commission Subcommittee Report dated March 2, 2016, as Exhibit 4; and the Kirkwood Code of Ordinances as Exhibit 5.

Zoning Administrator Ryan Spencer presented the matter to the council. Adding Learning Centers to the B-4 Zoning District was actually approved previously by the City Council years ago. It is believed that it is a clerical error that it is no longer listed. A brief discussion ensued.

There being no objection from the council this item was placed on the agenda as Item #2 and became Bill 10483.

- 1. Judy Post, 1129 S. Geyer, concerned about safety due to the trial posting stop signs on South Geyer. Inquired about the status of the trial posting of the stop signs. Mayor McDonnell stated that nothing has been scheduled yet, but when it is it will be placed on a council work session agenda for discussion.
- 2. Mary Ann Rea, 1308 S. Geyer, questioned if the new council members will be given all of the information, including citizen concerns, regarding the South Geyer trial posting stop signs.

# **OLD BUSINESS**

Motion was made by Council Member Ward and seconded by Council Member Biedenstein to bring Substitute Bill 10481 to the floor for consideration. The motion was unanimously approved.



Substitute Bill 10481, appropriating \$225,710 from the Sewer Lateral Replacement Program Fund Balance to Account #207-5701-410.31.10 for the City's portion to repair and replace failed sanitary sewer laterals, was brought before the council. Council Member Biedenstein requested that record reflect that the money collected for the Sewer Lateral Replacement Program is placed in a separate fund for the City's 75% contribution to claims made in this regard.

The bill, having received majority approval of the council, was adopted and became Ordinance 10330.

Motion was made by Council Member Ward and seconded by Council Member Luetzow to reconsider Substitute Bill 10480. The motion to reconsider failed with Council Members Luetzow, Sears and Ward in favor and Council Members Biedenstein, Jaksetic and Mayor McDonnell opposed.

## **NEW BUSINESS**

Bill 10482, appropriating donations for the Urban Forestry Commission in the amount of \$701.00 from the Donations Account to the Urban Forestry Account, was brought before the council. Motion was made by Council Member Luetzow and seconded by Council Member Biedenstein to accept the bill for first reading approval. The motion was unanimously approved.

The bill received first reading approval and was held over.

Bill 10483, amending provisions of the City of Kirkwood Municipal Code, Appendix A – Zoning, to add Learning Centers as a permitted use category in the B-4 Planned Commercial District, was brought before the council. Motion was made by Council Member Sears and seconded by Council Member Biedenstein to accept the bill for first reading approval. After discussion a motion was made by Council Member Luetzow and seconded by Council Member Biedenstein to amend the title of the bill to include "and in the B-5 Planned Commercial Development District." The motion to amend was unanimously approved. Motion was made by Council Member Luetzow and seconded by Council Member Jaksetic to amend the bill by adding a



new Section 2. to read as follows: "That the B-5 Zoning District of the City of Kirkwood Municipal Code of Ordinances, Appendix A – Zoning, Section A-540.2 is hereby amended by adding (33) Learning Centers and renumbering thereafter. The motion was unanimously approved. The motion to accept the bill as amended for first reading was unanimously approved.

The bill received first reading approval and was held over.

#### CITY COUNCIL REPORTS

Council Member Biedenstein requested that the City place on the website the list of streets that will be improved.

# **CHIEF ADMINISTRATIVE OFFICER REPORTS**

Mr. Hawes reported that the City of Kirkwood received a liquor license application from Sri Lakshmi, 10901 Manchester Road (BP Gas/Convenience Store) to sell intoxicating liquor in the original package, plus Sundays. Motion was made by Council Member Jaksetic and seconded by Council Member Luetzow to approve the application. The motion was unanimously approved.

Mr. Hawes reported that the City of Kirkwood received a Temporary Outdoor Promotional Variance Application for The Wood Cask, 10332 Manchester Road, to use parking spaces for a Corn Hole Tournament Fundraiser. Motion was made by Council Member Luetzow and seconded by Council Member Biedenstein to approve the application. The motion was unanimously approved.

#### CITY CLERK REPORT

Mrs. Montaño read the report of the April 6, 2016 Planning and Zoning Commission meeting. The following action took place.

1. Unanimously recommended approval of a Subdivision Waiver at 1126 Folger Avenue.



- 2. After the presentation for a Mixed Use Development in the B-2 Zoning District at 151 West Argonne Drive, the subcommittee (Mr. Klippel and Mr. Diel) scheduled a meeting at the site on April 13 at 8:30 a.m.
- 3. After the presentation for a Special Use Permit for a car wash for Lou Fusz Toyota at 10725 Manchester Road, the Commission recommended approval. A public hearing is required before the City Council. Barring objection from the council a public hearing will be scheduled for May 19, 2016.

Mrs. Montaño announced with the results of Tuesday's election a Special Election will be scheduled for August to fill the unexpired term of Council Member Griffin. She reported the City will advertise the election on April 8<sup>th</sup> and candidate packets will be available for pick-up beginning on April 12<sup>th</sup>. The opening day for candidates to file for the election will be 8:00 a.m. on May 3<sup>rd</sup> and closing day will be 5:00 p.m. on May 17<sup>th</sup>.
