Bill 10492, amending the Kirkwood Code of Ordinances, Chapter 3, "Alcoholic Beverages", by adding Sections 3-2 through 3-4 and deleting Sections 3-70, 3-145 and 3-146 regarding Liquor Licenses and Licensees, was brought before the council.

The bill, having received majority approval of the council, was adopted and became Ordinance 10340.

#### **NEW BUSINESS**

Bill 10493, granting a Special Use Permit Amendment for a car wash (Lou Fusz Toyota) on the property known as 10725 Manchester Road subject to certain conditions, was brought before the council. Motion was made by Council Member Sears and seconded by Council Member Duwe to accept the bill for first reading approval. A discussion took place regarding noise created by the car wash. City Attorney Hessel and staff will draft two amendments for council consideration, 1) to limit the use of the car wash to the hours of operation, and 2) as to what type of equipment would be allowed. The motion was unanimously approved.

The bill received first reading approval and was held over.

Bill 10494, appropriating donations for the Urban Forestry Commission from the Twenty-Five Gardeners of Kirkwood Club in the amount of \$350.00 from the Donations Account to the Urban Forestry Account, was brought before the council. Motion was made by Council Member



Ward and seconded by Council Member Luetzow to accept the bill for first reading approval. The motion was unanimously approved.

The bill received first reading approval and was held over.

Bill 10495, amending the Kirkwood Code of Ordinances, Chapter 14, Section 14-391, Schedule A: "Stop Intersections" to add stop signs for South Geyer Road (northbound and southbound) at Boxwood Lane and Windsor Lane, was brought before the council. Motion was made by Council Member Sears and seconded by Council Member Ward to accept the bill for first reading approval. A discussion took place. Staff will present alternative options to the council at their Thursday, June 9<sup>th</sup> work session, beginning at 7:00 a.m. The motion was approved with Council Member Duwe opposed.

The bill received first reading approval and was held over.

Resolution 67-2016, approving a Final Development Plan for a B-2 Mixed-Use project on the property known as 151 West Argonne Drive, was brought before the council. Motion was made by Council Member Ward and seconded by Council Member Sears to approve the resolution as read. A discussion took place.
