Pursuant to notice of meeting duly given by the Mayor, the City Council convened on Thursday, September 15, 2016, at 7:00 p.m. at Kirkwood City Hall, 139 South Kirkwood Road, Kirkwood, Missouri. Present were Mayor Griffin, Council Members Duwe, Edman, Luetzow, Sears, Ward, and Zimmer. Also in attendance were Chief Administrative Officer Russell Hawes, Assistant Chief Administrative Officer Georgia Ragland, Public Information Officer Beth von Behren, and City Attorney John Hessel. City Clerk Betty Montaño was absent and excused.

PUBLIC HEARINGS

Mayor Griffin recessed the meeting for the purpose of conducting a public hearing regarding a request to amend the Kirkwood Code of Ordinances, Appendix A: the City of Kirkwood Zoning Code, specifically Section 510: B-2 General Business District (Central Business District) Sections 510.2, 510.3 and 510.5. Mr. Hessel entered the following exhibits into the record: an Affidavit of Publication in the St. Louis Countian on August 30, 2016, as Exhibit 1; an Affidavit of Publication in the Webster Kirkwood Times on August 26, 2016, as Exhibit 2; the Planning and Zoning Commission Report dated August 17, 2016, as Exhibit 3; and the Kirkwood Code of Ordinances as Exhibit 4.

Director of Public Services Bill Bensing presented information pertaining to the request. Some of the items presented are as follows:

- During the review of the Preliminary Site Plan Madison Avenue B-2 Mixed Use Proposal, it was determined that a language clarification was needed, specifically Article V, Section A-510.5(2)(a).
- The zoning code change would require approval of any mixed-use development from Planning and Zoning Commission and the City Council.



The bill will be placed on the October 6, 2016 agenda for first reading consideration.

CITY CLERK REPORT

- 1. The motion to approve the site plan for St. John Vianney High School at 1311 South Kirkwood Road in accordance with the amended Sub-Committee Report passed by a vote of six to one.
- 2. The motion and amended Sub-Committee Report recommending approval of the Special Use Permit and Site Plan for a day care center known as Strictly Pediatrics at 449 and 451 Magnolia Avenue were unanimously approved by the six members present. Prior to proceeding to City Council, a revised site plan is required. *A revised site plan has been received and barring objection from the council a public hearing will be scheduled for October 6, 2016
- 3. A training session conducted by City staff and the City Attorney will be held on September 21, 2016.
