

- 3. Brief Description of the organization: The Webster Groves Nature Study Society (WGNSS) includes people of all ages and occupations who share an interest in learning about nature and the environment. Founded in 1920 by residents of Webster Groves, the society retains its original name for historical reasons but reaches far beyond the St. Louis area in its membership breadth and scope of its programs. Members enjoy educational programs, field trips and opportunities for social interaction throughout the year. Bird and Botany walks take place weekly. Entomology, Nature Photography and Nature Book Club meet once a month. WGNSS actively promotes the conservation of wildlife and preservation of natural habitats. Other WGNSS activities encompass educational and community outreach efforts. WGNSS encourages research and involvement in natural science and conservation through its scholarship and recognition programs. Our newsletter, Nature Notes, has a full description of these activities, and a calendar of events is also available on our website, www.wgnss.org . Visitors and guests are welcome at WGNSS activities and events. Beginners in birding, botany and entomology are encouraged to attend Society field trips and meetings. Come join us!
- 4. Project overview: (attach detail, maps, engineering, etc): James Earl Comfort's passion was birding. Most of his life he wandered the fields and forests in the St. Louis area observing birds. One of his favorite places to bird was Kirkwood Park. Not only did Earl watch birds, he also wrote prodigiously about them and was a mentor to many. He was a 40 year member of both WGNSS and the Missouri Audubon Society and a major contributor to each organizations newsletters. In recognition for all his birding work, on May 20, 1978 the city of Kirkwood designated the southwestern corner of Kirkwood Park to be the J. Earl Comfort Bird Sanctuary. A sign post was erected in Earl's honor and still stands in the park to this day.

Today, most people that pass the sign in Kirkwood Park do not know who Earl Comfort was and do not remember his significant contributions to Kirkwood Park. For those that try to find out more, there is very little to find on the internet. WGNSS would like to remedy this situation. In addition to the sign post, WGNSS proposes to a add a kiosk display next to the sign post. This display will include:

- a. A photo of Earl Comfort and description of his importance to Kirkwood Park
- b. Photos of birds likely to be found in the Bird Sanctuary
- c. Map of the Bird Sanctuary and trails
- d. Information about WGNSS

A photo of the proposed kiosk is attached. Its size is \sim 4 feet wide, 8 feet tall (2 feet of which is the two posts buried in the ground). WGNSS proposes to place the kiosk next to the current sign post, next to the jogging trail along Sugar Creek.

- 5. Location of Project: Kirkwood Park next to the current Earl Comfort Bird Sanctuary sign post, next to the jogging trail along Sugar Creek.
- 6. Project Start & Completion Dates (if known): Upon approval by the Kirkwood Park Board, it is anticipated that the purchase of the Kiosk will take up to two months. The display will likely take another month to complete. Installation of the kiosk in Kirkwood Park should take no more than one week.

Anticipated Use by Partner: The kiosk and its display are for public education.

- 7. At what times will the proposed project be available for public use? The kiosk and its display will be viewable by the public year-round.
- 8. Describe benefits to partner organization, the public, and Kirkwood Parks: Everyone benefits from an educational display. People will learn about an important citizen of Kirkwood. It is hoped that people will also gain a greater appreciation of the birds and natural history that are found within Kirkwood Park. In addition, WGNSS hopes that the kiosk will help to attract new members for our organization.
- 9. Annual User Demographic Estimates: Anyone 6 years old and up will be able to see and understand the display. It is not for infants.

Number of Kirkwood residents to benefit: Anyone who uses Kirkwood Park will have access to see the kiosk.

- 15. Does this proposed project conflict with the Parks Master Plan? No. However, should Kirkwood Park follow through on its master plan to remove Rifle Range Road, and place a bike path in its place, WGNSS would like to retain the right to move the Kiosk and sign post closer to this new trail.
- 16. Will this proposed project support uses that are lacking as defined by the Parks Master Plan? If yes, please list details.

WGNSS sees the kiosk and sign post as an educational opportunity for the public, and a benefit to all.

- 17. What conflicts might the proposed project cause with existing uses and users? WGNSS sees no conflict with existing uses and users.
- 18. Will public use of this proposed project generate any hazards or nuisances?

WGNSS is concerned that vandals could deface the kiosk, thus turning it into something no one wants to see. We would like to discuss ways to prevent this from happening with Kirkwood Park personnel.

19. What research has your organization done to assure compliance with Kirkwood City, state and federal ordinances?

WGNSS has not done any research to assure compliance with various government agencies. However, we believe this project is not likely to have any ordinance issues. WGNSS will rely heavily on the Kirkwood Parks department to guide us through the development of the project and notify us if something is lacking.

20. What steps will your organization take to assure compliance with the American with Disabilities Act?





Kirkwood Park Map





MAINTENANCE REPORT FOR MAY 2023 For Period April 18-May 15

McENTEE PARK:

The gazebo roof was replaced by Big Bear Roofing. We removed the boxwood bushes around the perimeter of the gazebo, and will be replacing with a low grow groundcover when all the work there is done. We also removed a dead pine, and mulched the beds. All this was done in preparation for the May 4 Day of Prayer which is annually held at the park. The Kirkwood Optimist Club continues to sponsor the park, having donated \$3000 towards the roofing project. And on May 20, the Club will host a work day to clean, prep and paint the gazebo. We plan to rededicate their sponsorship this summer.

PICKLEBALL COURTS OPEN:

We've all been waiting for the new courts to be christened. And the first week of May, Kyle, Brendan, Stephanie and Scout grabbed their paddles and were the first to play on the newly striped courts. Who won? They're not talking about it. In addition, we did some backfill and sod work, and installed a message/scheduling board at the curb line for coordinating play. The new courts are wildly popular!

RE-LAMPING ATHLETIC LIGHTING:

There were a number of lamps out on the tennis court bank courts 1-8 so we rented a tow behind lift and changed them out. Then when the winds finally subsided, we were able to use our aerial truck and changed out 3 lamps on one pole at Dia.#3. This eliminated a dark hole on the third base side.

MEACHAM MEMORIAL PARK:

As part of our annual preparation for the Meacham Park Homecoming celebration, we began our countdown list of tasks. The Hort crew sprayed all the beds for emerging weeds, pruned some woodys, and removed 2 dead crabapple trees. The Park crew, replaced b-ball nets, changed out the group BBQ grill with a suitable interim grill while we await delivery of a new one. We are getting a quote to replace the restroom doors, planning on doing some touchup painting, and will pressure wash the playgrounds, pavilion, and restroom exterior immediately prior to the June 3rd event. We will also prep and time the spray fountain the week before for the Memorial Day weekend startup.

BEER RUN, ARBOR DAY EVENTS:

As the special events folks for the City, our crews did significant prep and delivery for these two concurrent events. We provided delivery of trash barrels, EZup canopies, tables, chairs, traffic control devices, and trash bags. The Hort crew worked on all the endcaps on Argonne islands and site monitoring on the Saturday Arbor Day celebration. Recreation monitored and coordinated the Beer Run's 1000+ participants, and 4 Hands Brewery provided the libation.

DIRTBURNERS ELECTRIC SERVICE:

The electric disconnect and meter for the RC track was red flagged for replacement by Ameren. This required us to contract the work with a licensed electrician, pull permits and complete the startup. This debacle started unannounced by Ameren back in late February, and was completed May 4th. We were fortunate that the electrician was allowed to run a bypass around the disconnect so the club could begin their season with power. I am still waiting for a final invoice from the contractor but I am anticipating something over \$3000 for the work, parts and permits. Since we are the owner of the property, it is our responsibility to provide the electric to the end users. The cost will be partially offset by the lease proceeds from the Dirtburners Club.

IRRIGATION STARTUP:

Doug and Scott have been moving from site to site performing repairs and startup to irrigation systems. Most recently they had to replace parts at Fillmore as well as drip line which had more than a drip. They are now moving into the aquatic center, which usually requires about a week of repairs and replacements.

HORT CREW:

Both crews have been coordinating the return of our weekday volunteers, prepping beds, planting flowers, and finish pruning in the aquatic center. Our single seasonal assistant this year is Devin Callahan who has dug in like a tick and giving the team a much needed boost. Ron and Renee have been busting it out all over, making the system shine for Kirkwood. Annuals are being plugged in this week so be on the lookout for color popping!

MAINTENANCE REPORT FOR APRIL 2023 For period March 21 through April 16

MERAMEC FLOODING:

The spring surge rose quickly on March 28 to almost 6 feet above flood stage. It fell below flood stage even faster. We incurred no damage with just a few items relocated, and with impediments like goals capturing some small tedious debris. We spent a couple days removing the silt layer from trail and pavement surfaces and were then blessed with a very heavy, short lived downpour on the 31st which washed much of it off. Goals are back in place, the Dirtburners are running their races, the restroom is open, and the mowing contractor made his first cut at Greentree on the 10th. Picnic tables will be brought in closer to the first reservation date, just in case.

TENNIS CENTER PREP:

In the last couple of weeks, we hung all the tennis windscreens, cleaned up trapped leaves, changed out tennis lighting, trimmed branches away from lights, and draped the shade structures at the tennis courts. Pickle ball and tennis activity is in full swing. We are still waiting for the contractor to paint the new pickle ball courts due to temperature stability. They are planning for the week of April 10 last word.

SOFTBALL/BASEBALL FIELDS:

Gary did an amazing job prepping infields in a very small window of opportunity, and they were all ready as promised for practices and leagues. Dept. leagues began on schedule and the park is packed in the evenings.

BUILDINGS TAGGED AGAIN:

The amphitheater exterior, and 2 places on the pistol range were again tagged by a graffiti vandal with harmless but mindless drivel. It was wiped to a smudge the next day, and later the amphitheater was painted over. The pistol range is probably going for a later date when they can paint the entire building. Police dept. has installed surveillance cameras in a number of spots and hope to lead to some arrests. Most of the activity seems to trail to/from a railroad crossing point near the Couch water tower. Not a surprise...

MOWING BEGINS AS NECESSITY DICTATES:

While we have begun mowing in Kirkwood Park, we are deferring many areas to a later date, to try and accommodate NO MOW APRIL. The small wildflowers and even flowering weeds are blooming in many of the turf areas, and the honeybee and solitary bee populations are reaping the early pollinator benefits. We have never been a monoculture turf program here, which does afford this luxury, however, we have begun to mow high where turf is clumping and tufting up and looking ragged. Most of the mowing we do right now is high enough that it doesn't affect the small flowering vegetation.

THE 'HORT' CREW IS ON TOP OF IT:

Renee, Ron and our newest seasonal Devin are out shakin' the bushes! They are moving from place to place cleaning, planting, even weeding with volunteers already. From the aquatic center to around the lake to KPAC and SBD, they can be seen just about anywhere making our grounds look so much better. It's all in the details...

MITCHELL PARK CHARRETTE:

The first of 2 public presentations by DG2 Architects was held at the Kirkwood Early Childhood Center. In addition to public comment there, a great sampling of opinions was collected online and added to the mix. A second public presentation will take place in a few weeks after a site interpretation and other stakeholder parties are given the opportunity to opine. Kyle will have the details soon.

EMMENEGGER PARK STRIPING:

Thanks to Wes and Doug from the Street Division, all the parking spaces and directional arrows at Emmenegger Staging Area have been painted – professionally. We were about down to invisibility after all the construction and flooding over the last 5 or so years. The difference is remarkable and pleasing to the eye.

EMMENEGGER PAVILION ROOF:

The brutal gale force winds we had in both February and March, and again in April have made a mess of the western exposure of the pavilion roof. Quotes are being collected to roof either just the western pitch or the entire building. Winds have literally raised large portions of shingles up and flapped them up and down. The eastern exposure is untouched, and may not need to be replaced. After our numerous attempts to secure and reset the west side, it is obvious it will have to be dealt with this summer. More to follow...

GREENTREE/DIRTBURNERS ELECTRIC SERVICE:

The Ameren UE meter that serves the racetrack at Greentree Park, was removed by Ameren due to its condition. They had mercy on us and performed at temporary bypass until a licensed electrician can come in and replace the corroded elements. This too was unforeseen with Ameren taking the lead, and with Parks having to foot the bill for the service. As soon as permit and parts can be lined up, the electrician will perform some \$3-4k dollars of restorative work.


The volunteer program has had a busy spring! The YTD hours are comparable 2019 and are a 78% increase from 2022.


Highlights

North Kirkwood Middle School held Pursuit Week, a four-day event where students explored topics of their choosing. Parks hosted the Serve St. Louis group on Thursday, March 16. Students and teachers assisted horticulturists, Ron and Renee, with prepping the Aquatic Center for its May opening. Volunteers weeded landscape beds, picked up sticks and gathered more than eight truckloads of leaves. Additionally, I received an invitation to speak to the Conservation group about invasive bush honeysuckle and Parks management practices.

Parks is collaborating with the Police Department to capture aerial photographs of the Historic Quinette Cemetery. Volunteers spent a Saturday morning placing red markers on each gravesite. Volunteers cleared most of the invasive bush honeysuckle from the property earlier in the spring. This revealed a portion of a hog wire fence and four headstones hidden beyond the cemetery's current boundary.



Q2 How often do you visit Mitchell Park?




