

City Council Meeting Minutes Kirkwood City Hall Thursday, September 7, 2023, 7:00 p.m.

Pursuant to notice of meeting duly given by the Mayor, the City Council convened on Thursday, September 7, 2023, at 7:00 p.m. at Kirkwood City Hall, 139 South Kirkwood Road, Kirkwood, Missouri. Present were: Present were Mayor Griffin, Council Members, Duwe, Gibbons, Luetzow, Sears, Wurtz, and Zimmer. Also in attendance were Chief Administrative Officer Russ Hawes, Assistant Chief Administrative Officer David Weidler, City Clerk Laurie Asche, Deputy City Clerk Bridget Waters, and Assistant City Attorney Sarah White.

PRESENTATIONS

The Greentree Festival Committee presented information regarding the 2023 Greentree Festival. The theme will be "Celebration of Transportation". The festival will take place from Friday, September 15th through Sunday, September 17th. The parade will take place on Saturday, September 16th starting at 10:00 a.m.

PUBLIC HEARINGS

Public Hearing #1

Mayor Griffin recessed the meeting for the purpose of conducting a public hearing establishing the Property Tax Rates for the City of Kirkwood. Assistant City Attorney Sarah White entered the following exhibits into record: an Affidavit of Publication in the St. Louis Countian on August 11, 2023, as Exhibit 1; an Affidavit of Publication in the Webster-Kirkwood Times on August 11, 2023 as Exhibit 2; and the Kirkwood Code of Ordinances, as Exhibit 3.

Assistant Director of Finance Jennifer Forgy presented the matter to the Council:

- Residential assessments increased by 14%. Residential assessed value is 19% of the appraised value.
- Commercial assessments increased by 20%. Commercial assessed value is 32% of the appraised value.
- The process of calculating the proposed property tax rates allow the taxing authority to capture revenue at the same level as the previous year, plus an increase for the Consumer Price Index (CPI). This year CPI was 6.5%.
- All proposed property tax rates are calculated and reviewed by the Missouri State Auditor's office.
- The City levies property taxes for the Police & Fire Pension, Parks, and general government services that include public safety.
- The residential proposed rate is 45 per 100 of assessed value. The City of Kirkwood property tax levy historically averages 7% of a resident's total tax bill.
- The commercial proposed rate is 52.5 per 100 of assessed value.
- Personal property proposed rate is 72 per 100 of assessed value.



• The Special Business District's (SBD) commercial assessments increased by 19% with a proposed rate of 34.3 per 100 of assessed value.

Public Hearing #2

Mayor Griffin recessed the meeting for the purpose of conducting a public hearing establishing the Property Tax Rates for the Kirkwood Municipal Library. Assistant City Attorney Sarah White entered the following exhibits into record: an Affidavit of Publication in the St. Louis Countian on August 11, 2023, as Exhibit 1; an Affidavit of Publication in the Webster-Kirkwood Times on August 11, 2023 as Exhibit 2; and the Kirkwood Code of Ordinances, as Exhibit 3.

Assistant Director of Finance Jennifer Forgy presented the matter to the Council:

- Residential assessments increased by 14%.
- Commercial assessments increased by 21%.
- The Library taxing district boundaries are not the same as the City of Kirkwood, which explains the difference in the assessed values and percentages.
- The residential proposed rate is 21.2 per 100 of assessed value.
- The commercial proposed rate is 24.9 per 100 of assessed value.
- The personal property proposed rate is 35.5 per 100 of assessed value.
- The Kirkwood Library property tax levy historically averages 3% of a resident's total tax bill.
- The property tax levy funds the operations of the Kirkwood Public Library.

Bill 10997, amending Chapter 24 "Tree Code" by deleting it in its entirety and inserting a new Chapter 24 "Tree Code" was brought before the City Council. Motion was made by Council Member Luetzow and seconded by Council Member Wurtz to accept the Bill as read. A discussion took place.

The bill received first reading approval and was held over.

Bill 10998, fixing and establishing the rate of taxation to be levied upon all real estate and certain tangible personal property in the City of Kirkwood, County of St. Louis, State of Missouri, for the year 2023, for the maintenance of the Kirkwood public parks; for the Police and Firemen's Pension Fund; for general government services and for businesses in the Special Business District was brought before the City Council. Motion was made by Council Member Duwe and seconded by Council Member Zimmer to accept the Resolution as read. A discussion took place.

The bill received first reading approval and was held over.

Bill 10999, fixing and establishing the rate of taxation to be levied upon all real estate and certain tangible personal property in the City of Kirkwood, County of St. Louis, State of Missouri, for the year 2023, for the operation and maintenance of the Municipal Library District of Kirkwood was brought before the City Council. Motion was made by Council Member Luetzow and seconded by Council Member Zimmer to accept the Resolution as read.

The bill received first reading approval and was held over.

Bill 11000, amending Chapter 14, Article I, Section 14-1 and Article VII, Section 14-385, and deleting Section 14-386 of the Kirkwood Code of Ordinances was brought



before the City Council. Motion was made by Council Member Luetzow and seconded by Council Member Wurtz to accept the Resolution as read. A discussion took place.

The bill received first reading approval and was held over.

Resolution 102-2023, accepting the bid of Contemporary Landscape in the amount of \$103,241.75 for Kirkwood City Property Grounds Maintenance for the Forestry Division for an initial term of 12 months with the option to renew for up to four additional terms and authorizing and directing the Mayor to enter into a contract was brought before the City Council. Motion was made by Council Member Duwe and seconded by Council Member Luetzow to accept the Resolution as read. A discussion took place.
