

### City Council Meeting Minutes Kirkwood City Hall Thursday, November 2, 2023, 7:00 p.m.

Pursuant to notice of meeting duly given by the Mayor, the City Council convened on Thursday, November 2, 2023, at 7:00 p.m. at Kirkwood City Hall, 139 South Kirkwood Road, Kirkwood, Missouri. Present were: Present were Mayor Griffin, Council Members Duwe, Gibbons, Luetzow, Sears, Wurtz, and Zimmer. ## **PUBLIC HEARINGS**

Mayor Griffin recessed the meeting for the purpose of conducting a public hearing regarding a request for a Special Use Permit for an Indoor Amusement Facility (Little's Loft Play Café) at 117 W. Argonne. Mr. Hessel entered the following exhibits into records: an Affidavit of Publication in the St. Louis Countian on October 13, 2023, as Exhibit 1; an Affidavit of Publication in the Webster-Kirkwood Times on October 13, 2023 as Exhibit 2; a list of properties that were notified of the hearing; as Exhibit 3; an aerial view map showing the subject property, as Exhibit 4; the report of the Planning and Zoning Commission from City Planner II Amy Lowry dated October 4, 2023 as Exhibit 5; the letter from the Planning and Zoning Commission dated October 5, 2023 as Exhibit 6; and the Kirkwood Code of Ordinances, as Exhibit 7.

City Planner II Amy Lowry presented the matter to the Council:

- The applicant is requesting a Special Use Permit for an Indoor Amusement Facility
- The lot is 7000 sq. ft. and the building is 3909 sq. ft.
- No more than 3200 sq. ft. will be devoted to the play area
- Days and hours of operation for the play café are proposed as 8 a.m. to 4 p.m. seven days a week.
- Employees and outside vendor instructors may offer classes to the clientele
- The applicant will have 3-4 employees during peak hours, and 2-3 at other times
- A café is proposed for the business, but this use is subordinate to the play component
- It will be open to members of the public without a play appointment
- A café would fit under the use category of a restaurant which is a permitted use in the B-2 zoning district
- In the B-2 Zoning District, an indoor amusement facility requires a special use



permit

• The facility is located on the North side of Argonne Drive, across from Kirkwood Train Station

Petitioner Hannah Campbell and Jennifer Beazley, Attorney for the petitioner were in attendance to discuss the request for Special Use Permit with Council.

Some of the discussion that took place is as follows:

- Concerns about how the reservations and play pass will work
- Concerns about staffing between peak hours
- Concerns about the food beverage options
- Concerns about outside toys and floor covering in the play area
- Are County Health inspections required for this type of facility

The bill will be on the November 16, 2023 Council meeting agenda under New Business.

## CITY COUNCIL REPORTS

Mr. Hawes reported that the City of Kirkwood received an request from the Kirkwood Optimist Club to operate its annual fundraising tree lot at North Middle School with set up on November 11, 2023 and tree lot opening on November 24, 2023 with hours of operation 4:00 p.m. to 9:00 p.m. Thursday and Friday, and 9:00 a.m. to 9:00 p.m. Saturday and Sunday was brought before the City Council. Council Member Wurtz and seconded by Council Member Zimmer. Motion passed unanimously.

Mr. Hawes reported that the City of Kirkwood received an Application for Liquor License to sell Intoxicating Liquor by the Drink, plus Sunday, from Kokuu Kirkwood, LLC, 343 S.
