#### **CITY CLERK REPORTS**

Ms. Asche read the report of the March 20, 2024 Planning and Zoning Commission meeting. The following action was taken:

1. By a vote of 6-0, the Commission recommended approval of a staff-initiated zoning text amendment (1) to add hours of operation to the use-specific standards for the Personal and Commercial Service use in the B-1 zoning district, and (2) to allow for extension of hours of operation through approval of a



special use permit in the use-specific standards for the Personal and Commercial Service, Restaurant, and Retail Business uses in the B-1 zoning district. A public hearing is requested on this text amendment.
