

SCIT Report / Recommendations

Old Business

- Grandview Drive Petition. Rebecca Schuder <u>rlschuder@sbcglobal.net</u>. 2023 Speed Survey conducted September 2023 (The radar trailer was placed on Grandview between August 29th and September 20th, 2023)
 - a. **SCIT Action:** Russ Hawes directed Gary to put out speed trailer again and compare that data with new speed data program that will be in place April 2024.
- 2. **Erratic and Unsafe Driving 600 Block of Argonne Speed Study Request.** A request for a speed study was sent 3/10/2024). Resident was concerned with speed violations and erratic driving.
 - a. **SCIT Action:** Police will place speed trailer, will review records and compare with Urban SDK Program when installed in April 2024 and review at next SCIT meeting.
- 3. Parked cars near Rosehill and Edgewood. (submitted by Gary Baldridge)
 - a. Cars on Rosehill parking too close to Edgewood making it difficult for vehicles to exit safely onto Rosehill.
 - b. **SCIT Action:** Engineering will review the site to confirm parking condition and have Street Department install "No Parking Here to Corner" if warranted.
- 4. **Temporary Speed Bump Placement: East Glenwood Lane** 200-300 off of Big Bend Boulevard and on **West Glenwood Lane** near Ferncliff Lane After April 1
 - a. **SCIT Action:** Engineering will direct Street Department to install temporary full-width speed humps and advanced warning signs at the following locations:
 - Briargate Lane, approximately 100 feet north of cart path, just south of "No Parking " sign, and
 - ii. West Glenwood Lane, approximately 100 feet from end of concrete at Briargate Lane and West Glenwood Lane Intersection.
 - iii. Evaluate effectiveness with new Urban SDK software at June's SCIT meeting.

New Business

- 1. Increase Stop Bar Minimum Spacing from Crosswalk from 4 feet to 20 feet (Michael Carmody)
 - a. **SCIT Action:** SCIT reviewed and discussed. No action to be taken at this time.
- 2. Stop Sign for Pedestrian Crosswalk between Geyer Road and just north of Windsor Springs Drive. Received Petition (31 entries) on March 18, 2024
 - **a. SCIT Action:** SCIT reviewed and discussed. No stop sign is warranted. Street Department to install crosswalk striping and supporting signing across Geyer Road, just north of Windsor Springs Drive.
- 3. Speeding on West Essex between Guyer and the High School
 - **a. SCIT Action:** SCIT will review Urban SDK data and report at the next SCIT meeting **-END-**
