## SCIT Report / Recommendations

### Old Business

1. **Grandview Drive Petition for Speed Study.** Rebecca Schuder [rlschuder@sbcglobal.net](mailto:rlschuder@sbcglobal.net). 2023 Speed Survey conducted September 2023 (The radar trailer was placed on Grandview between August 29<sup>th</sup> and September 20<sup>th</sup>, 2023)
  - a. **SCIT Action:** Speed trailer out of service; StatTrak speed data program collected data April 2024. Based on the collected speed data, it was determined that no speeding issue exists. Petitioner contacted.
2. **Erratic and Unsafe Driving – 600 Block of Argonne Speed Study Request.** A request for a speed study was sent 3/10/2024). Resident was concerned with speed violations and erratic driving.
  - a. **SCIT Action:** StatTrak placed today. SCIT will review speed data with consultant Lochmueller and Urban SDK and present results at next SCIT meeting.
3. **Parked cars near Rosehill and Edgewood.** Cars on Rosehill parking too close to Edgewood making it difficult for vehicles to exit safely onto Rosehill.
  - a. **SCIT Action:** Engineering reviewed and determined that “No Parking Here to Corner” is warranted. Sign installed by Streets.
4. **Stop Sign for Pedestrian Crosswalk between Geyer Road and just north of Windsor Springs Drive.** Received Petition (31 entries) on March 18, 2024
  - a. **SCIT Action:** SCIT reviewed and determined that no stop sign is warranted. Street Department to install crosswalk striping and supporting signing across Geyer Road, just north of Windsor Springs Drive. Continental Crossing Striping designated. Streets marked for sign location on April 30<sup>th</sup> with City Engineer and striping installed week of May 13, weather permitting.
5. **Speeding on West Essex between Geyer and the High School**
  - a. **SCIT Action:** SCIT will review Urban SDK data and Engineering will report at next SCIT meeting
6. **Temporary Speed Bump Placement: East Glenwood Lane 200-300 off of Big Bend Boulevard and on West Glenwood Lane near Ferncliff Lane After April 1**
  - a. **SCIT Action:** Signs posted and temporary speed humps installed by Streets on May 8<sup>th</sup>. Engineering to monitor effect and report at September SCIT meeting

### New Business

1. **Rename SCIT Committee**
  - a. **SCIT Action:** SCIT determined that no name change is warranted at this time.

**2. West Glenwood Lane near Ferncliff Lane cart path crossing advanced warning signing.**

- a. **SCIT Action:** Addition of advance Golf Cart crossing signing (WW11-11) before and after cart path is not warranted at this time.

**3. City Source Request for no left turn sign (R3-2) from the easternmost Tillman Elementary school entrance onto Quan.**

- a. **SCIT Action:** SCIT determined that this intersection does not warrant a “No Left Turn” sign at the subject location.
