

City Council Meeting Minutes Kirkwood City Hall Wednesday, July 3, 2024, 7:00 p.m.

Pursuant to notice of meeting duly given by the Mayor, the City Council convened on Wednesday, July 3, 2024, at 7:00 p.m. at Kirkwood City Hall, 139 South Kirkwood Road, Kirkwood, Missouri. Present: Mayor Gibbons, Council Members Jaksetic, McLean, Rheinnecker, Schaefer, and Zimmer. Also in attendance were Chief Administrative Officer Russ Hawes, Assistant Chief Administrative Officer David Weidler, City Clerk Laurie Asche, Planning & Development Services Director Jonathan Raiche, Public Services Director Chris Krueger, City Planner I Lauren Hoerr, and City Attorney John Hessel. PUBLIC HEARINGS

Mayor Gibbons recessed the meeting for the purpose of conducting a public hearing a request for a Special Use Permit for Outdoor Dining for Café Napoli at 436 North Kirkwood Road. Mr. Hessel entered the following exhibits into the record: An Affidavit of Publication in the Countian on June 14, 2024, as Exhibit 1; An Affidavit of Publication in the Kirkwood-Webster Times on June 14, 2024 as Exhibit 2; a list of properties that were notified of the hearing as Exhibit 3; an aerial view map showing the subject property, as Exhibit 4; Memorandum from the Planning and Zoning Commission with exhibits dated May 31, 2024, as Exhibit 5; a report from the Planning and Zoning Commission with a vote of 7-0 recommending approval of Special Use Permit for Outdoor Dining for Café Napoli at 436 North Kirkwood Road dated June 6, 2024, as Exhibit 6; and the Kirkwood Code of Ordinances as Exhibit 7.

City Planner I Lauren Hoerr presented the matter to the Council:

- 436 N Kirkwood Rd is located on east side of N Kirkwood Rd between East Washington and East Bodley Avenues – just south of the Alpine Shop
- The building is a mixed use, 5-story building
- The covered dining area is about 1,037 square feet, with approximate dimensions of 16.83' wide by 62.5' long
- While the Code does not require additional parking for this outdoor seating, if it were evaluated as restaurant floor area, it would still meet the City's requirements for parking
- The restaurant is required to have 40 parking spaces
- The days and hours of operation are proposed as 11:00 am 10:00 pm Monday through Thursday, 11:00 am – 11:00 pm on Fridays and Saturdays; and 11:00 am – 9:00 pm on Sunday
- Applicant anticipates 15-20 total employees



• Applicant is also requesting outside entertainment in the form of speakers during the restaurant hours of operation

Petitioner's representative Paul Fusz was in attendance to discuss the Special Use Permit with the Council. Some of the discussion that took place is as follows:

- Questions raised about speaker placement
- Concerns about if the outdoor seating will go into the public outdoor plaza
- Concerns were raised about how loud the outdoor speakers will be
- Questions raised about employee parking and customer parking

The bill will be placed on the July 18, 2024, agenda for first reading consideration.

Bill 11037, granting a Special Use Permit for outdoor dining at 10935 Manchester Road, Suite 200 (Snarf's Sandwiches) subject to certain conditions was brought before the City Council. Motion was made by Council Member McLean and seconded by Council Member Zimmer to accept the Bill as read.

The bill received first reading approval and was held over.

Bill 11038, changing the zoning from B-4, Planned Commercial District, to B-2, Central Business District, on the property, known as 119 West Woodbine Avenue being an approximately 0.21 acre site on the north side of West Woodbine was brought before the City Council. Motion was made by Council Member Schaefer and seconded by Council Member McLean to accept the Bill as read. A discussion took place.



The bill received first reading approval and was held over.

Bill 11039, appropriating \$349,100 from the General Fund Balance to the Machinery and Equipment Account for ERP Project Management Consulting Services was brought before the City Council. The bill received first reading approval and was held over.

Resolution 101-2024, accepting the bid of K.J. Unnerstall Construction in the not to exceed the amount of \$716,367.68 (which includes a contingency of \$76,753.68) for water main replacement on Rayner Road and Taylor Drive and authorizing and directing the Mayor to enter into a contract was brought before the City Council. Motion was made by Council Member Zimmer and seconded by Council Member Schaefer to accept the Resolution as read. A discussion took place.

Motion was made by Council Member Zimmer and seconded by Council Member Schaefer to amend Resolution 101-2024 to replace Taylor Drive with Taylor Young Drive wherever it is listed in the Resolution. The motion to amend was unanimously approved.
