a. Aquatic Center Update.

-Oakland back out of the resident agreement in November, Glendale resigned the contract.
-About \$355,000 of repair work done, \$170,000 was to remove and strip the old paint on Leisure and lazy river. \$60,000 in broken pipes and resealing repairs, \$100,000 for the competition wall/pump room wall bracing project, and \$25,000 on SCS repairs and replacing rotting boards.

-After the fixes the pump room leaks have slowed, but there are still leaks coming up from the ground.

-Back to school hours will start on August 12th.

b. Staffing Updates.

-Only two positions left to fill, Head Dive Coach and Aqua Fitness instructor.

c. Kirkwood Riptides Update.

-We have 240 kids this year, which is the same as last year.
