COURT ORDER

**VIOLATIONS BUREAU SCHEDULE OF OFFENSES AND FINES
EFFECTIVE August 18, 2015**

Pursuant to 479.050, RSMo, Supreme Court Rule 37.49, the undersigned Municipal Judge of the City of Kirkwood hereby orders that the following designated offenses shall be payable to the City of Kirkwood Violations Bureau. In such cases, no court appearance is necessary.

This schedule is divided into four parts. Part I consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule for moving violations (points). Part II consists of the St. Louis County Municipal Court Uniform Traffic Violation Schedule for non-moving violations. Part III consists of the City of Kirkwood Violation Schedule for moving and non-moving violations which are not part of the Uniform Traffic Violation Schedule. Part IV consists of ordinance violations which can be paid out of court as imposed by the City of Kirkwood.

In accordance with Missouri statutes and ordinances adopted by the City, total court costs shall be \$26.50. This includes Court Costs of \$12.00 COR21.01 (a) 4, Crime Victim's Compensation Surcharge of \$7.50, 488.5339.1 RSMo; Law Enforcement Training Fund of \$2.00, 488.5336.1 RSMo; Peace Officer's Standard Training Fund of \$1.00, 488.5336.1 RSMo; and Inmate Security-Biometric Verification System Surcharge of \$2.00, 488.5026 RSMo; and Shelter for Battered Victims of \$2.00, 488.605 RSMo; for a total of \$26.50. Court costs shall be paid in addition to the fine listed below, unless otherwise stated.


