<u>Case No. 29-2018</u> Nathan Rauh with Naismith-Allen, Inc., applicant for 3 Orchard Way (R-1 Zoning District) requests a variance to construct an addition that will not conform to the side yard setback of the Zoning Code.- **Unanimously Approved**

Case No. 30-2018 Ryan Meeks with THD Design Group, applicant for 11818 Big Bend Blvd (R-3 Zoning District) requests a variance to construct an addition that will not conform to the rear yard setback of the Zoning Code.- **Unanimously Approved**
