### **Committee Reports**

<u>Partnership Committee</u> – The Partnership Committee has not met since the last Park Board meeting but I would like to see about setting up the next meeting.

<u>Trail Committee</u> – No further meetings have been held, but this would be a good opportunity to consider next steps for the committee.

<u>Finance Committee</u> – Minutes from the Finance Committee meeting held in December are included in the packet. I plan on distributing budget documents to those Board members who are not on the Finance Committee at the meeting. The current plan is to hold a public hearing on the proposed budget at the February meeting and pass the budget at the March meeting. The new budget would become effective April 1, 2020.

### **Unfinished Business**

<u>Strategic Planning Update</u> – this represents the monthly opportunity to provide updates on any actions taken relative to the strategic plan.

<u>I-44 Meramec River Pedestrian Bridge</u> – At this point I do not have anything new to report other than the design development process has been delayed somewhat. I have left this on as an agenda item to make sure we do not lose sight of this important topic.

### **New Business**

<u>Eagle Scout Project Presentation</u> – At its last meeting the Board approved the concept of adding a Gaga Ball court in near the playground in Kirkwood Park. There was a sentiment expressed by the Board that the Eagle Scout candidate present his plan for installation at a Board meeting. The candidate plans to be on hand with a short presentation on the installation process.

<u>Complete Streets Consortium Report</u> – Superintendent of Recreation Kyle Henke attended the Complete Streets Consortium meeting earlier in January and will have a brief presentation outlining what he learned.

Meacham Memorial Sprayground Replacement — We have received a proposal from Westport Pools to replace the current sprayground at Meacham Memorial Park. The proposed replacement is a single vertical spray fountain, similar to the setup here in Kirkwood Park. The existing ground level sprayground is problematic and should be replaced. Westport is under contract to the City for pool repairs and this project falls within the scope of work of that contract. Westport's proposed price is \$43,104, well within the project budget of \$50,000. I would ask that the Board approve the proposed costs plus a contingency of \$6,896, bringing the total authorization to the full project budget of \$50,000. The contingency is appropriate as there is potential to discover some hidden, underground plumbing issues that might impact the project. Costs should be charged to account 201-5101-452-7504 (Park Improvements) Project PF2003 (Meacham Sprayground).

<u>Maintenance Report</u> – Curt's report is included as is the report from Ron Hall. A spring calendar of volunteer events has been provided by Kylie.

IN ATTENDANCE: The meeting was called order at 7:00 p.m. with Chair Steve Coates, Alan Hopefl, Kathy Paulsen, Dave Hufford, Peggy Grever, Alvin Reid, Scott Stream, Jordan Wienke and Staff Liaison Murray Pounds, Curt Carron and Kyle Henke in attendance.

### I. CITIZEN COMMENTS

Gwyn Wahlmann, 1002 West Adams, spoke about her concerns with design and parking at the I44 pedestrian bridge.

### II. APPROVAL OF NOVEMBER 18, 2019 MEETING MINUTES

A motion made by Scott Stream, seconded by Kathy Paulsen. Motion approved unanimously.

### III. COMMITTEE REPORTS

- a. Partnership Committee The Committee introduced their final draft of the memorial application. The Board will vote on it during the unfinished business of this meeting and Murray will reach out to interested parties with the updated application process.
- b. Trail Committee Steve Coates spoke about the potential trails along the north side of Kirkwood Park, connecting Couch and Geyer roads. The Board discussed their concerns about environmental impacts, costs and feasibility. The Trail Committee will meet again and present and updated plan at the next meeting.
- c. Finance Committee Murray would like to schedule a meeting the first week in January.

### IV. UNFINISHED BUSINESS

- a. I-44 Meramec River Pedestrian Bridge update Murray discussed the last meeting of the Technical Advisory Committee (TAC). They are recommending a design that includes 20 parking space and the scenic overlook for design development. The scenic overlook is the lowest priority item the TAC discussed and will be cut if cost for the more desired elements exceed the budget.

  Jordan Wienke. Motion approved unanimously.

### II. UNFINISHED BUSINESS

a. None

### **III. NEW BUSINESS**

- a. Establish Budget Calendar The budget packet will be distributed to the remainder of the Park Board at the January 27, 2020 monthly meeting. The public hearing on the budget will be held February 24 and passage of the budget will be scheduled for March 16.
- b. Review of Park Property Tax Revenue History Murray Pounds reviewed information on the recent history of property tax revenue. Over the last ten years it does not appear that property tax revenue has kept pace with the increase in property values. At the same time salary costs have nearly doubled making it difficult to maintain the fund balance. Murray is currently working with the City's Finance Director to make sure the Park Fund is receiving its proper share of property tax received from the state. Other revenue enhancement ideas are being researched.
- c. Review of Draft Park Fund Budget for Fiscal Year 2020-21 The draft of the 2020-21 Park Fund budget was reviewed. Only a very small increase in revenue is forecast. Significant increases for salary, health insurance and worker's compensation premiums have driven up expenses significantly to the point where some capital projects need to be delayed to maintain a proper fund balance.
- d. Review of Draft Park Fund Five Year Capital Plan Two projects, totaling \$110,000 in value were placed on hold in the plan. They are resurfacing the road leading to the inner parking lot at Quarry Park and title signs at Meacham Memorial Park. The remaining projects, including vehicle replacement, safety surfacing at Walker Park and field irrigation were determined to be of higher priority.
- e. Other Matters Discussion was held regarding the possible replacement of the restroom at the Grant's Trail trailhead. Staff will be seeking assistance from Great Rivers Greenway District for this project.

### MAINTENANCE REPORT FOR JANUARY 2020 For Period Dec 17 through Jan 26

### PAVILION/GAZEBO PROJECTS:

The Gazebo project is completed except for installation of a donor plaque. The surrounding grounds have been restored and seeded with a straw mat covering. Following settling this spring we will either re-seed heavily or sod the perimeter. The final touch will be installation of the plaque and the light fixture which is outstanding from Schaeffer Electric.

The Campbell Pavilion is nearly completed as well. The contractor is here this past week installing the standing seam metal roofing and ice bars. The stone mason finished the columns the previous week. The final work to install the lighting fixtures and receptacles will take place before the end of January. The plaque denoting the donor will be installed upon delivery. The perimeter will be graded and landscaped this spring. Currently our crews are installing a drinking fountain along the sidewalk, and I have a group sized grill and trash receptacles on order. The entire project should be dressed and completed in February.

### WINTER STORM RESPONSES:

The couple of mild winter storms have been responded to with relative ease. Typically we have a supervisor and a maintenance staffer on duty and we have not had both onboard at the same time to date. Responses have been mostly chemical and not plowing due to the sleet and ice which has fallen. To date this season we have used about 63 tons of salt for the SBD and Park removal duties.

### TREE REMOVALS:

We have removed the 6 Pin oak trees in the concession plaza. The trees have been dying a slow prolonged death over the last 5 years or more. The shallow root environment and surrounding and underlying pavement made for less than desirable growing conditions. The trees were chlorotic and dieback was annual. The trees were removed before any root damage or upheaval of the donor brick plaza had occurred. They will be replaced with 6 Gingko trees. We will remove the stumps and bedding soil as deep as necessary, and install root channelers before planting. The root channelers will be vented allowing feathery feeder roots maneuverability within the planting site, but are designed to direct the anchoring roots downward instead of outward, where the sidewalk and plaza would be disturbed. The trees have been located and will be tagged and held until late this winter when we will pick them up and install them.

We have also removed a big Black oak which stood near the spraypad in the playground. The tree has had some spontaneous shedding of large limbs recently and has shown dieback over the last couple of years. The tree was becoming a hazard and had to be removed. Since removal, we are planning the site to hold the Gagaball court proposed by staff and an Eagle Scout candidate. That will be installed in February.

TRAINING OPPS:

Senior Ranger Ron Hall ventured to N. Carolina for the Park Ranger Institute early in January. The weeklong educational institute is designed specifically for Park Rangers of all grades and rank. It is held on the campus grounds and attendees are fed and boarded on campus. This is the 4<sup>th</sup> such trip Ron has made for this training. He is also scheduled to attend the annual PLEA conference held this year in Arkansas. The Park Law Enforcement Assn. holds an annual conference similar to MPRA's conference with educational session and broad opportunity for networking. The Park crew is scheduled to attend an MPRA Safety Day workshop at the Lodge of DesPeres on the 22<sup>nd</sup>. The entire crew will attend an all-day educational training session held annually by MPRA.

**BALLFIELD MAINTENANCE:** 

All chain link fences in field of play have been outfitted with new protective ABS covering. The bright yellow ABS corrugated piping is slit and made to install over the top edge and rail of chain link fences. This provides a measure of safety as well as visibility to the fields. We replaced approx. 1100 ft. of covering on 4 fields. In addition, we have received Council approval to install automated lighting controls for fields 5 & 6. The controls will be the same as we've equipped fields 3 & 4 with over the past few years. Musco lighting which lights almost everyone's athletic complexes will provide the equipment and contract it out to be installed by their sub who has installed our other devices. The \$43,000 contract was an appropriated Capital item within the Recreation budget, started before Don LaChance left for Olivette.

### FLOOD SEASON BEGINS:

The annual flood season along the Meramec has begun with a moderate overage at 24ft, which is 8ft above flood stage at Greentree Park. We were prepared for the flood, having removed bleachers, picnic tables, trash receptacles, goals and restroom supplies prior to the over-topping of the banks. Cleanup was immediately delayed by the sub-freezing temperatures which froze the mud to the pavements throughout the valley. The surge was very quick rising some 23ft over a 5 day period following heavy rains in early January.
